Maharshi Karve Stree Shikshan Samstha's , Cummins College of Engineering for Women (CCEW), Maharshi Karve Stree Shikshan Samstha educational institute registered with the Charitable Trust being a registered public Trust formed under the Indian Trusts Act, 1882 within the jurisdiction of the District Registrar of Assurances, vide registration no.9264 hereinafter referred to as "CCEW" which expression unless repugnant to the context herein shall mean and include each of its Trustees, its legal heirs, successors and permitted assigns of the Second Part;

'Party' and 'Parties' shall mean 'MBRDI' and 'CCEW' individually and jointly where referred.

- MBRDI is desirous of launching a scholarship program for women in Mechanical and allied specializations named as "Mercedes in Mech"
- CCEW is one such educational institute which fulfils the legal eligibility requirement and accordingly

# NOW, THE PARTIES TO THIS UNDERSTANDING AGREE TO BE ASSOCIATED FOR THE PURPOSE AND DURING THE VALIDITY OF THIS MOU AND ABIDE BY THE TERMS AND CONDITIONS APPEARING HEREINAFTER

1. Effective Date: This MOU shall be effective from February 28, 2017

#### 2. Term and Termination:

- 2.1 This MOU shall be valid until December 31, 2020 from its effective date.
- 2.2 Termination: This MOU may be terminated by either Party by serving on the other Party a written Notice of thirty (30) days in advance informing its intention to terminate this MOU.
- 2.3 On termination being acknowledged by the other Party, both the Parties shall jointly review the status of the initiatives and accordingly arrive at a mutually agreement to the status of the project and payments, obligations if any.

### 3. Scope:

- 3.1 CCEW shall support MBRDI in smooth roll out of "Mercedes in Mech" scholarship.
- 3.2 CCEW shall administratively facilitate the payout of the scholarship amount to the selected students.
- 3.3 CCEW shall allow MBRDI to use its premises for the "Mercedes in Mech" selection process, promotional events and various developmental interventions from time to time.
- 3.4 CCEW shall allow the students to participate in the said Program, promotional events and various developmental interventions.
- 3.5 MBRDI reserves the right to withdraw the scholarship without assigning any reason.
- 4. Work Instructions: During the validity period of this MOU, MBRDI may undertake identical or similar initiatives, as it may think fit through any other entity and CCEW agrees and acknowledges that since this being a non-exclusive MOU, MBRDI is free to choose any other entity / agency for this purpose.
- Change of Stream: Subjected to fulfillment of eligibility pre-requisites, CCEW administration shall support students to change the stream to mechanical engineering. The final discretion for the same rest with CCEW.
- Eligibility: Eligibility of the students shall be governed by the relevant parameters laid down while implementing the program.
- 7. Grants: Grant Amount shall mean such amount under the program applicable from time to time.

#### 8. Terms of payment:

- (c) dismissal of any student involved in unethical behavior / suspension / misbehaving and criminal case.
- No assignment/transfer: CCEW shall under no circumstances assign its rights and obligations under this MOU to any third party.
- 13. Notice: Any notice by one Party to the other Party shall be in writing and posted, delivered personally with proper acknowledgment or sent by courier, registered or certified mail or facsimile transmission to the other Party's last known address and/or the address as specified hereto.
