Mrs. Meghana Vaidya communicated her inability to attend the meeting. Dr. Mrudul Dixit could not attend the meeting. Absence of these IQAC members were approved by IQAC.

Following points were discussed & decisions were taken in the meeting.

Point No. 1] To confirm the minutes of the previous IQAC meeting.

Decision : Minutes of the previous IQAC meeting were confirmed.

Point No. 2] To review the report of NBA accreditation.

Discussion : Dean - Academic informed the CDC members that an expert team of NBA conducted onsite evaluation of the programs from 11<sup>th</sup> to 13<sup>th</sup> November, 2022. On the basis of evaluation report submitted by expert team, the competent authority in NBA has approved the following accreditation status to the programs as given in the table below.

Point No. 3] To discuss the status of NAAC accreditation application.

Discussion : Dean – Quality Assurance informed the IQAC members that the NAAC SSR has already been submitted in December, 2022. Moreover, the queries received after the DVV processes have also been addressed by the college and the college SSR has been accepted by NAAC. He also informed that NAAC communicated 11<sup>th</sup> & 12<sup>th</sup> May, 2023 as the dates of the peer team visit to the College.

Decision : To create awareness of the details provided in the NAAC self-study report of the college, it was decided to give a detailed presentation of the SSR to all the faculty members. Also, it was decided to conduct meetings with all the students in view of the upcoming peer team visit.

Point No. 4] To review the semester - 1 result for the A.Y. 2022-23.

Discussion : Dean – Examinations presented a summary of the semester - 1 result to all the IQAC members. (Refer to the annexure IQAC/20.04.2023/A).

Decision : Dr. P.V.S. Shastry noted that the results of the S.Y. BTech. Examinations for Instrumentation and Control Engineering and Mechanical Engineering show that a higher proportion of students achieved a lower SGPA than other branches. It is important to identify the reasons for this trend and take corrective action to improve the academic performance of these two branches. Dr. Ajit Bhosale explained that more admission of direct second year took place for Instrumentation and Control Engineering and Mechanical Engineering branches than other branches which hamper the overall SGPA. He added that the departments are taking steps to improve their SGPA in coming semester and overall CGPA can be improved. He added that detail result discussion is done with all Head of Department.

Point No. 5] To review the implementation of the perspective plan of the institute.

Discussion : Dean – Quality Assurance presented a summary of the findings of the Perspective Plan Review committee's meeting. (Refer to the annexure IQAC/20.04.2023/B.)

Decision: The IQAC members appreciated the overall progress of the implementation of the perspective plan. It was decided to take more efforts to promote faculty members for consultancy assignments.


Point No. 6] To review the student satisfaction survey.

Discussion : Dean – Quality Assurance presented the student satisfaction survey.


Decision : It was observed that the student satisfaction level is high and the responses to the survey were seen to be predominantly positive.
